- Please make all your case filings for the Court via Missouri CaseNet. Timely Entries of Appearance are expected for each case. If, for some reason, your electronic access is impaired, please contact the court for further direction. My contact information is below.

- Effective April 2023, Court is held on the 3rd Thursday of each month at 6 PM (CST). The Honorable Mark Rundel sits as city judge. The courtroom is located on the city square in Galena. (City Hall and the court is relocating in the Spring of 2023 to a new location, but still on the square.)

- Before contacting me, please review this helpful information:
 - Initial contact/requests should be initiated at least 2 weeks prior to the assigned court date, if possible.
 - Please review my current Driver Improvement Program (DIP) Policy (<https://www.ozarkslg.com/downloads/galena-DIP.pdf>). **I expect each attorney to screen their own client against this policy.**
 - If your client falls within the DIP Policy, you can reach out to me (e-mail preferred) for my preliminary thoughts on what an official offer will look like. I expect you to be clear in your email as to the status of your client's DIP status and what you are asking.

Just know, I am firm on the DIP policy and will not submit a formal offer to the court until such time the DIP and/or other agreed programs are completed.

Once the DIP and/or other programs are completed, please forward the Certificate(s) of Completion to me.

- When you do contact me, please provide your direct contact information, including your best e-mail address and phone numbers. This is not my full-time position and I don't want to waste valuable time repeatedly playing phone tag. (Thank you!)
